## TOWN & COUNTRY LOBBIES ARE NOW OPEN

We're excited to announce that our lobbies are now open again, with the exception of our location in the Fargo Sanford Broadway Medical Center which remains closed due to visitor restrictions at the hospital.

Now, we ask you to join us in taking precautions to keep all of us healthy when you come in:

- Use the hand sanitizer that's available near the entrance.
- Maintain a 6-foot distance whenever possible. Stickers are installed on the floor for you to stand on while waiting in line.
- Plexiglass germ guards have been installed on our teller lines. Please stand behind them while conducting your business.
- Masks are allowed, but not required in our branches. If you choose to wear a mask, we ask that you do not wear anything else to obstruct the view of your face such as a baseball cap, sunglasses or a hood.
- Do not come in if you're feeling sick. Give us a call or access your account online to conduct your business.



If you need to meet with an account opener or loan officer, call us at 1-800-872-6358 to make an appointment. When you get to the branch, wait in your car until your scheduled appointment time.

We've also increased our cleaning protocols, limited lobby seating, and clean our workspaces between every member interaction as an added precaution. Thank you for your patience in allowing our staff to complete these activities before serving the next member in line.

Thank you for your understanding during our lobby closure and for following these precautions. Working together, we can all move forward.
